



Welcome to the 43rd Annual Williamston Spring Water Festival!

****Setup and Registration:****

- Setup and registration currently TBT. Final dates and times to come.
- Representatives will be available in the park on TBT, to assist you with any information you may need. You can find them at the General Information/Souvenir Booth located at the Gazebo in the center of market vendors..

****General Rules:****

1. ****Prohibited Items:**** Do not sell any items related to or associated with sex, drugs, alcohol, etc.
2. ****Product limitation:**** Products will be limited to 2 like Vendors. Exceptions for MLM vendors (Scentsy, Mary Kay, etc) as those vendors are only allowed 1 vendor per market. Once we have reached the limit applicants will be notified that they are on the waitlist. Payments not received by August 1, 2024 will forfeit the vendor spot and move to the next in line on the waitlist.

Market will only be filling 50 vendor spots for 2024 due to excessive complaints during the prior year event..

3. ****Vendor Space:**** Your vendor space(s) will be marked with your space number, provided to you the week of the event or available for pickup at the information booth on the day of the festival. Each vendor space will measure 11 ft. x 11 ft. All assigned spaces are permanent to avoid confusion.

4. ****Vehicle Access:**** No vehicles will be allowed to drive into the vendor space to unload! Vendors can unload on the side of Gossett St. to the sidewalk. Be courteous to others and move your vehicle before taking all items to your space. **PARKING IS NOT ALLOWED ON THE VENDOR GRASS AREA NOR THE SIDE OF GOSSETT ST.**

5. ****Parking:**** Please unload at Gossett St. beside the park, then park your vehicle in the area designated by event staff. One parking pass will be allowed per space. Space Number will be written on the parking pass and **must be** displayed in the car window. Any cars not designed to park in that area will be TOWED by the Town of Williamston. Note again no cars will be allowed in the grass area where vendors are set up. Be sure to bring carts if needed to take items to your booths.

6. **Shade and Shelter:** Vendors are responsible for providing their own tents for shade or in case of rain. Security will be provided, if the event runs 2 nights, on Friday night. Setup of tents, tables, etc., is permitted on TBT.

7. **Tax Identification Number:** Please bring your Tax Identification number. A representative from the SC Dept. of Revenue can show up at the festival to check this information.

8. **Item Approval:** Applicants must include a picture of all items they plan to sell at the festival with their application.

9. **Electricity:** If you require electricity, please indicate this on your craft application form. Electricity availability is limited and provided on a first-come, first-served basis.
